Mayor & Council Minutes July 7, 2021 Apprours

The monthly meeting of the Keedysville Mayor and Town Council was called to order at 7:00pm with the following members present: Assistant Mayor Brandon Sweeney, Council Members Judy Kerns, Matt Hull, and Sarah Baker, Town Attorney Ed Kuczynski, Town Administrator Rick Bishop, and Assistant Town Administrator Lisa Riner.

The minutes for the June 2, 2021 meeting were approved.

General Fund report was \$221,736.29.

Mr. Sweeney read the announcements from the agenda.

Community Deputy Report: Deputy Tracey Peyton completed 59 dedicated checks in Town, 3 hours of foot patrol, and 7 traffic assignments, where he issued 5 warnings and 3 citations. He assisted out of Town twice.

Ms. Riner noted that there is an MML dinner July 26, and she needs to know who will attend. There should be plenty of attendance at the dinner to cover the Banner Town requirements.

Ms. Riner said the Town is officially admitted to the Sustainable Maryland program and the Green Team will have their first meeting on Thursday, July 29 at 7pm in Town Hall. During the last week of August, Mike Hunninghake, the leader of the program, will meet with the Green Team in Keedysville to do some training.

Ms. Baker received a few more quotes for road paving. She also spoke with Boonsboro about their road paving contracts and met with a representative from Huntzberry.

Mr. Bishop said he has filled out and submitted the ARP paperwork. The amount received by the Town won't be more than \$300,000.

Mr. Sweeney met with a company about getting an alarm in Town Hall and is waiting for them to submit a quote.

Mr. Bishop said the Town will present to the County Commissioners on July 20 about doing an MOU for the County to take over the Town's permitting.

Mr. Bishop presented three quotes for mulching and weeding at Taylor Park and the Library. After some discussion, Mr. Hull motioned to go with Pam Edwards, who is a Keedysville resident and gave the lowest quote. Ms. Kerns seconded and all voted in favor.

Mr. Hull made a motion to reappoint Matt Rhoads to the Planning & Zoning Commission. Ms. Baker seconded. All voted in favor.

Mr. Bishop noted the Little Free Library is up in front of Town Hall. The Town agreed to pay \$300 to Jason Simmons for it, and the Ruritan is also paying \$300 towards it. Resident Sue Gemeny recommended getting a little plaque for it that notes it was donated by the Ruritan and the Mayor & Council.

Ms. Gemeny suggested that the Town could send out a letter regarding the Town weed ordinance to residents along Main Street who are not maintaining their little garden area. She also recommended including Pam Edwards' information in case they would like to ask her to maintain it for them.

Eric Matson said he spoked to Mr. George Nagel at Fox and Associates about the gap created during annexation of his property and that it is considered an enclave. Mr. Matson intends to de-annex his property and inquired about whether this should be presented to the Mayor & Council or Planning & Zoning. Mr. Hull said it should go before the Mayor & Council. Mr. Kuczynski said the process will also depend upon what Mr. Nagel's final determination is.

Mr. Matson also noted that he would like to saw within the gap that is considered County property since Mr. Bishop has said he is only allowed to use his sawmill inside his building. Mr. Kuczynski said he can't address it tonight, but will look at Mr. Nagel's final determination when it is available.

Justin Holder forwarded an email to the Town and asked that it be included with the minutes of this meeting. It is an email he sent to the Maryland Department of Natural Resources in which he claims that DNR has kept files from him regarding ownership of a certain piece of property. The email and attachments will be included with the minutes of this meeting.

Mr. Hull will not be able to attend the next Planning & Zoning meeting, so another Council member will need to attend. Mr. Sweeney agreed to go.

Ms. Riner read a thank you card from Jamie Shoemaker to the Mayor & Council for their donation to the Leukemia and Lymphoma Society.

Meeting adjourned at 7:24pm.

the doctrine of non-resistance against arbitrary power and oppression is absurd, slavish and destructive of the good and happiness of mankind.

## the Court:

"It is conceded that no suit can be brought against the State, without its consent. This immunity of the State from suit rests upon grounds of public policy, and is too firmly fixed in our law to be questioned. But it would be strange indeed, in the face of the solemn constitutional guarantees, which place private property among the fundamental and indestructible rights of the citizen, if this principle could be extended and applied so as to preclude him from prosecuting an action of ejectment against a State Official unjustly and wrongfully withholding property, by the mere fact that he was holding it for the State and for State uses.

"It is easy to see the abuses to which a doctrine like that would lead. That such is not the law has been conclusively settled by *United States v. Lee,* 106 U.S. [196] [1 S.Ct. 240, 27 L.Ed. 171]; *Tindel [Tindal] v. Wesley,* 167 U.S. 204 [17 S.Ct. 770, 42 L.Ed. 137 (1897)]; *Smith v. Reeves,* 178 U.S. 438 [436] [20 S.Ct. 919, 44 L.Ed. 1140 (1900)]; 10 *Am. and Eng. Ency. of law,* 528." 110
