Water Commission Minutes June 1, 2022

Approved

The monthly meeting of the Keedysville Water Commission was called to order at 8:18 pm with the following present: Mayor Ken Lord, Assistant Mayor Brandon Sweeney, Council Members Matt Hull, Judy Kerns, and Sarah Baker, Town Attorney Ed Kuczynski, Town Administrator Lisa Riner, and Administrative Assistant Teresa Pangle.

The minutes from the May 4, 2022 meeting were approved.

General Fund report was \$122,762.74.

There were no announcements.

Ms. Baker motioned to pass the Joint Resolution for the Water System Maintenance Program. Mayor Lord seconded and all voted in favor. The RFP for the program is ready to go out.

There are no updates on the water asset inventory, radio tower reads, or booster pump station pressure study.

The water line replacement RFP is ready to go out.

The Fiscal Year 2023 Water Budget was approved at the Mayor and Council Meeting.

Mr. Sweeney brought up the possibility that the Town may need to get a recirculation pump for the water tank after Boonsboro replaces its reservoir. The engineering may have been done previously when the tank was built. Mr. Hull suggested that they may only need to adjust the schedule for draining and refilling the tank. There was some discussion.

The water valves broken by the plow on Stonecrest Circle, Village View Court, and Skyline Court have been fixed. Ms. Baker suggested identifying valves that are at risk of getting hit by the plow and having someone come out to pave around them.

Meeting adjourned at 8:27 pm.
