

**CHAPTER 27**

**TOWN OF KEEDYSVILLE**  
**ORDINANCE TO RAISE SALARIES OF MAYOR AND COUNCIL**

**Recital**

The Charter of the Town of Keedysville allows periodic raises for the Mayor and Council of the Town of Keedysville. Pursuant to the Charter salary raises cannot take effect until after the next election(s). The Charter of the Town at Section 33 specifies that the Mayor and Council shall serve staggered terms with the Mayor and one (1) Councilperson standing for election for a term of four (4) years and then two (2) years later the Assistant Mayor and two (2) Councilpersons shall be elected for four (4) year terms. As a result, any salary increases or decreases shall not take effect until the newly elected Mayor, Assistant Mayor and Councilpersons take office following the next two elections. The next Mayor and one (1) Councilperson shall be elected to serve four (4) year terms in the election scheduled for the first Saturday of May 2020. The other two (2) Councilpersons shall be elected in the election scheduled for the first Saturday of May 2022. Thus, any salary increases pursuant to this Ordinance shall not take effect and/or be implemented until the aforesaid are elected.

**NOW THEREFORE, BE IT RESOLVED, ENACTED AND ORDAINED** that the salary of the Mayor of the Town of Keedysville be and is hereby raised to the sum of **Three Thousand (\$3,000.00) Dollars** per year; and be it further

**RESOLVED, ENACTED AND ORDAINED** that the salary of the Assistant Mayor of the Town of Keedysville be and is hereby raised to **Two Thousand Two Hundred (\$2,200.00) Dollars** per year; and be it further


**RESOLVED, ENACTED AND ORDAINED** that the salary of each Councilperson be and is hereby raised to the sum of **One Thousand Eight Hundred (\$1,800.00) Dollars** per year; and be it further

**RESOLVED, ENACTED AND ORDAINED** that these salary raises shall become effective and shall be implemented following the aforementioned elections in accordance with the Charter of the Town of Keedysville.


