Planning & Zoning Commission Minutes May 11, 2023

The monthly meeting of the Keedysville Planning & Zoning Commission was called to order at 7:02pm with the following present: Members John Puffenbarger, Jeff Russell, and Jacqueline Piro, Alternate Tom Clemens, and Town Administrator Lisa Riner.

The minutes from March 9, 2023 were read and approved.

There were no announcements.

The Commission voted to table the Container Regulations until the Short-Term Rental Regulations were ready so that a hearing could be held for both at the same time.

The Short-Term Rental Regulations were also tabled until they could get an update from Town Attorney Ed Kuczynski.

Ms. Riner distributed some examples from other municipalities of 5G and Cell Tower Regulations. There was some discussion about changing the title to allow for broader inclusion of what the regulations could cover in the future. One suggestion was Innovative Wireless and Tower Regulations. The Commission will review the examples for the next meeting.

Antietam Broadband requested to put up the cable on the poles in Keedysville. They have permission from Potomac Edison. Antietam emailed a draft Franchise Agreement to Ed. There was some discussion.

Mr. Puffenbarger suggested that the Planning & Zoning meetings go back to being quarterly since the Comprehensive Plan Update is on hold until they hear back about the grant application. The meetings would be in

January, April, July, and October. Mr. Clemens motioned to move the meetings to quarterly. Ms. Piro seconded. All voted in favor. The next meeting will be on July 13, 2023.

The meeting adjourned at 7:51pm.
