WASHINGTON COUNTY HAZARD MITIGATION PLAN

RECITALS

- 1. Natural, technological, and man-made hazards can affect Washington County.
- 2. Significant structural, historical, and economic losses could result from an occurrence of a natural, technological, or man-made hazard events.
- 3. Undertaking mitigation projects during pre-disaster periods could decrease the total losses Washington County incurs as a result of said hazard occurrences.
- 4. The Mayor and Council of the Town of Keedysville, Maryland, has a strong interest in reducing losses from future hazard occurrences.
- 5. The hazard mitigation plan is a federal and State requirement to maintain eligibility for hazard mitigation funding, and, by that requirement, must be updated a minimum of every five (5) years.
- 6. A cooperative, joint effort is a proven efficient way to plan for and reduce hazard susceptibility in all government jurisdictions in Washington County, Maryland.
- 7. The Washington County Division of Emergency Services has undertaken a project to update the existing *Washington County Hazard Mitigation Plan* in an effort to further identify, define, and characterize the hazards affecting Washington County as well as to continue identifying and prioritizing projects that could lessen hazard vulnerability.
