A JOINT RESOLUTION of the Mayor and Council of Keedysville, Maryland approving and authorizing the submittal of a Management Plan for the certification of the Heart of the Civil War Heritage Area.

WHEREAS, Washington, Frederick and Carroll Counties and their numerous municipalities, in partnership with the Heart of the Civil War Heritage Area Steering Committee has prepared a Management Plan to designate portions of Washington, Frederick and Carroll Counties and many municipalities including Keedysville, Maryland as a Certified Heritage Area as part of the Maryland System of Heritage Areas, a copy of which is attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, the Heart of the Civil War Heritage Area has important environmental, recreation, and cultural resources, as well as significant historical sites and districts on the National Register of Historic Places including the Keedysville Historic District; and

WHEREAS, the Management Plan presents strategies for enhancing these resources, improving linkages, advancing economic development strategies, and providing for stewardship and preservation; and

WHEREAS, the Management Plan will compliment other State and County initiatives in the Certified Heritage Area; and

WHEREAS, upon approval of the Management Plan and the Certified Heritage Area proposed by the Maryland Heritage Areas Authority, and if it chooses to avail itself and its citizens of the advantages of Heritage Area certification, the Town of Keedysville will amend its Comprehensive Plan to adopt the portions of the Management Plan relevant to the Comprehensive Plan as a strategy to implement the Comprehensive Plan; and

NOW, THEREFORE, be it jointly resolved by the Mayor and Council of Keedysville that the Management Plan and the proposal to request that the Heart of the Civil War Heritage Area become a Certified Maryland Heritage Area, attached hereto as Exhibit A, be and the same is hereby approved and the Heart of the Civil War Heritage Area Steering Committee is hereby authorized on behalf of the Town of Keedysville to

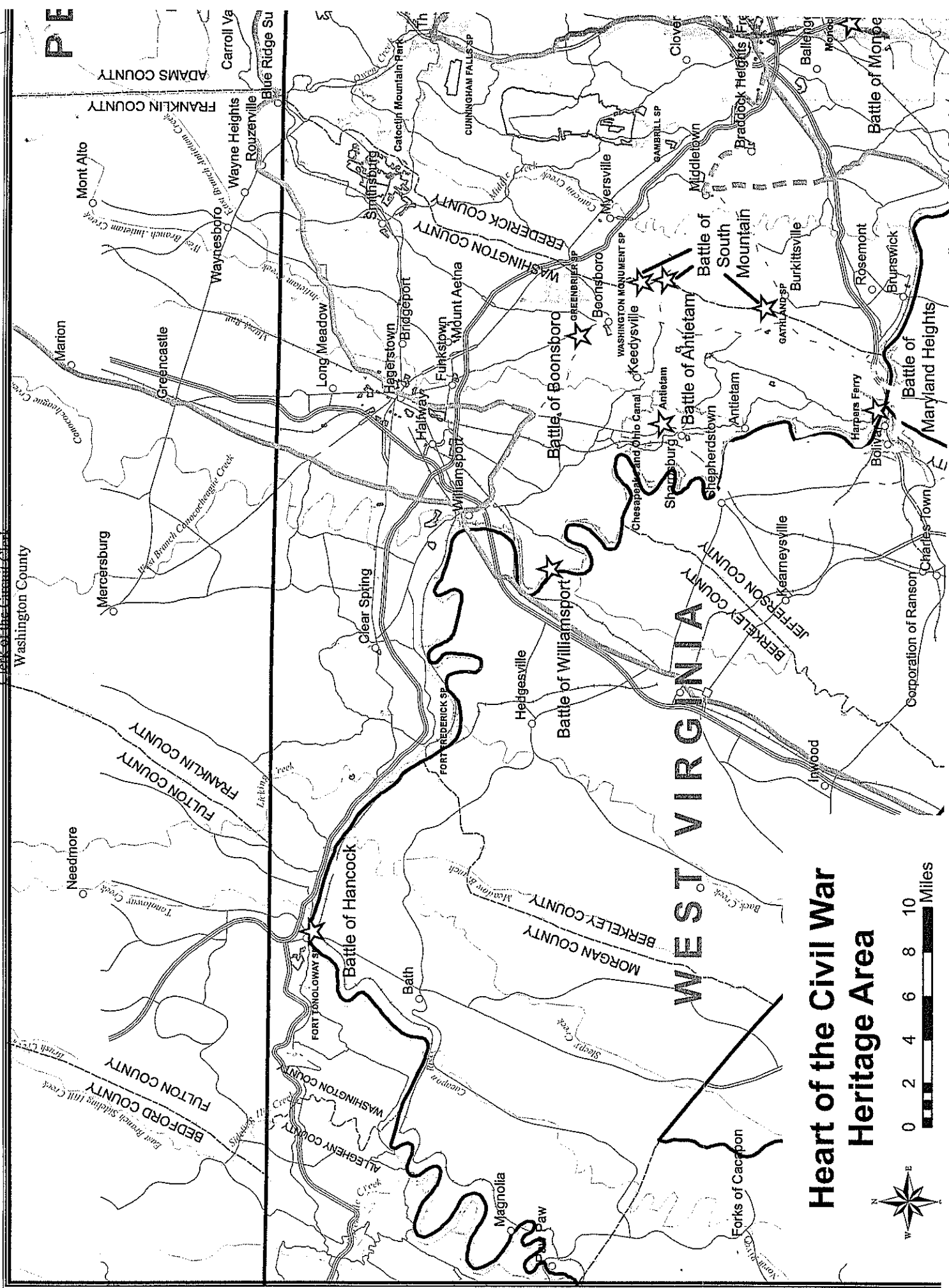

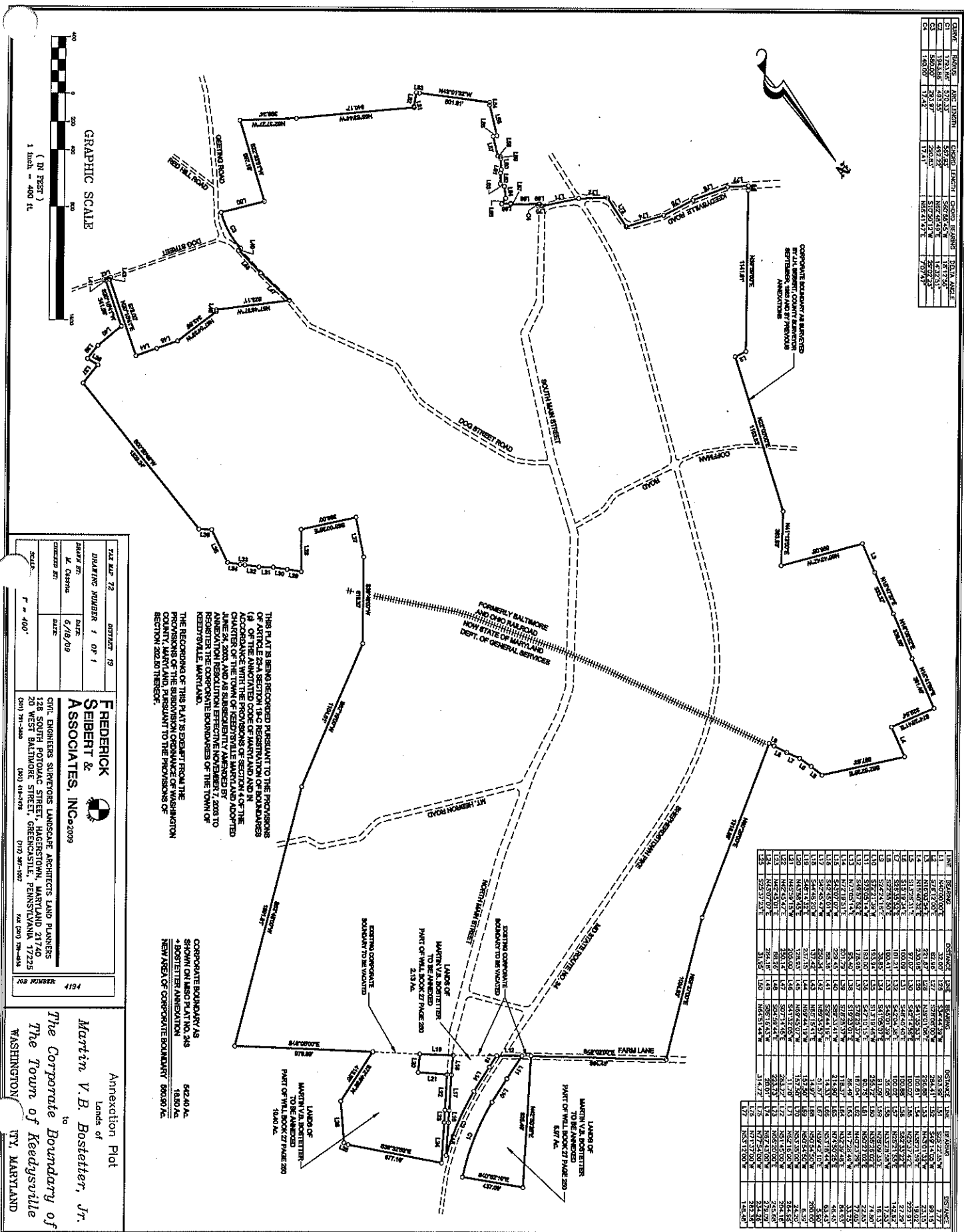

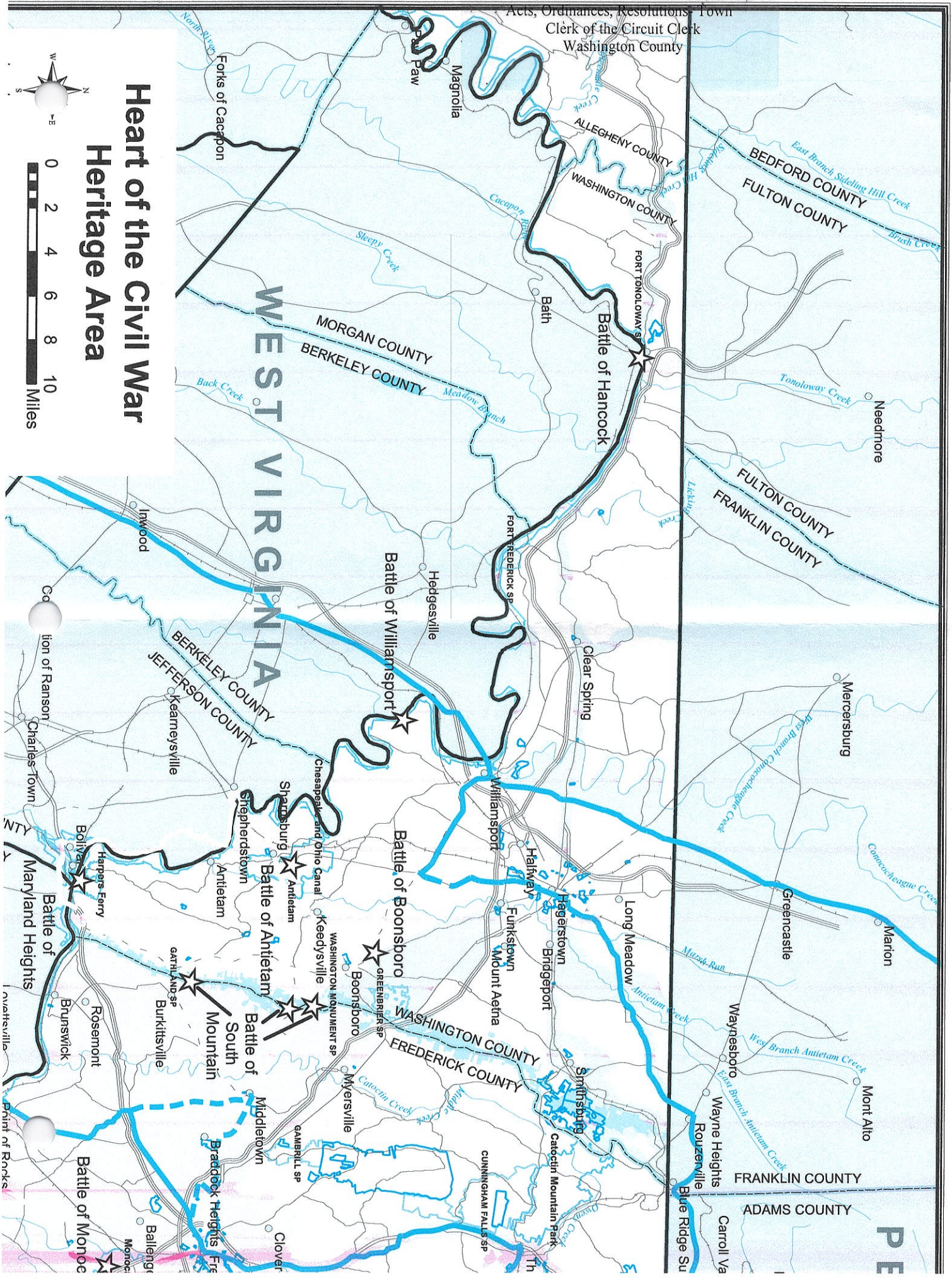
Maryland System of Heritage Areas
