BE IT FURTHER RESOLVED that said stormwater management parcels are and shall be a part of the Stormwater Management System of the Town of Keedysville; and

**BE IT FURTHER RESOLVED** that the acceptance of this offer of dedication is conditioned upon the following conditions precedent and shall not be considered a valid acceptance until same are met:

- 1. A deed from DRB Financial Corporation, Owner, for the property described to the Town, free and clear of any liens, encumbrances or mortgages.
- 2. Compliance with all requisite conditions, appropriate specifications and standards of Washington County, Maryland, the Town of Keedysville, Maryland, and with all Acts, Ordinances and regulations applicable to the construction of said stormwater management parcels.
