## **Water Commission Minutes December 6, 2023**

The monthly meeting of the Keedysville Water Commission was called to order at 7:40 pm with the following present: Mayor Ken Lord, Assistant Mayor Brandon Sweeney, Council Members Judy Kerns, Matt Hull, Sarah Baker, Town Attorney Ed Kuczynski, Town Administrator Lisa Riner, Administrative Assistant Teresa Pangle.

### Old Business

Tank Maintenance – Mr. Sweeney said they did a test where they isolated the tank and we are good to move forward. Southern Corrosion will probably be back once it warms up, around March or April. Mr. Sweeney requested they give us at least a 2 week notice.

Lead & Copper Rule – Ms. Riner is working on the spreadsheet. There is a question about the properties with double meters being one line or two. Mr. Hull said to go with they are all one line. There was much discussion about figuring out the lines going into the homes to see what material is there. Ms. Riner said Maryland Rural Water may offer some kind of assistance but they have not told us yet. They have started helping people on the Eastern Shore. Mr. Sweeney suggested reporting on the Town's portion of the service line, but not to do anything with the resident side until we are given some means of support. There was a discussion about putting information in the next newsletter for residents to check their side of the service line and voluntarily report their findings.

### New Business

Mr. Sweeney reported that Huntzberry came back with replacing a 10" water valve for a total of \$13,640.00. Ms. Riner will talk to Mr. Shumaker to get this scheduled.
