New Business

2024 Water Rates – Ms. Riner reported this went out in the newsletter. Rates are going up per the 2021 amendment. The 2024 fixed fee rate is \$33.00 per EDU, the debt fee rate is \$19.00 per EDU. Less than 15,000 gallons is \$10.72 per 1,000 gallons, and more than 15,000 gallons is \$13.79 per 1,000 gallons.

Mayor Lord mentioned, just for the record, a resident complaint over the holidays about why there are so many ongoing sewer issues on the north end of Town. The County does come out whenever there is an issue.

Mr. Hull motioned to move \$150,000.00 from the water fund to a CD, Ms. Kerns seconded and all voted in favor.
