Lead Service Line Inventory – Ms. Riner said the inventory was submitted on the deadline with Boonsboro. The next step is to send a letter to everyone who is unknown, lead or galvanized. The letters have to go out by November 15th. The State has supplied a letter to use.

Bedrock Replacement Engineering – Mr. Sweeney said they had a kickoff meeting that went well and the company provided meeting minutes. They started surveying this week. Ms. Riner asked them to send pictures because the grant organization wants it for their annual newsletter. They sent pictures of them surveying around Town.

ACH Water Payments – Ms. Riner said online water payments have been available to Boonsboro residents but not for Keedysville residents. Ms. Riner said Boonsboro recently bought GIS software so we can go in on it with them since it's a joint system. Mr. Hull motioned to go with the \$9,800.00, Ms. Kerns seconded and all voted in favor.
