Mayor and Council Minutes June 5, 2024

The monthly meeting of the Keedysville Mayor and Town Council was called to order at 7:00 pm with the following present: Mayor Ken Lord, Assistant Mayor Brandon Sweeney, Council Members Judy Kerns, Matt Hull, Sarah Baker, Town Attorney Ed Kuczynski, Deputy Dakota Watkins, Town Administrator Lisa Riner, and Administrative Assistant Teresa Pangle.

Minutes from the May 1, 2024 meeting were approved.

The General Fund Report was \$256,479.83

No Announcements

Community Deputy Report

Deputy Watkins reported the following checks, 13 in Cannon Ridge, 13 in Rockingham, 13 in Stonecrest, 6 in the Cemetery, 10 in the park, 3 at the filtration plant, 11 calls for service, 1 day for Court, vehicle swap and attended Town meeting.

Lyndell Clipp (Crop Walk) – Mr. Clipp spoke about this year's Crop Walk on Sunday, October 13, 2024, at 2 pm in Taylor Park. The Ruritans will serve free lunch/drinks to walkers starting at 1 pm. Non-walkers can purchase lunch and the Ruritans donate that money back to the Crop Walk. Rohrersville Community Band will play from 1:00 to 1:50 pm. 25% of the money raised will go to the South Washington County Emergency Fund to support food and utility assistance. Last year they raised \$15k. Mr. Clipp said it would be nice if someone from the Council could be there at 2 pm to welcome the walkers to Keedysville.

Old Business

Park Sign – Mr. Sweeney motioned for the blue park sign without the bird perches from Tim Fraker Signs, Ms. Baker seconded, and all voted in favor.

Town Hall Address Plaque for Building – Mr. Sweeney motioned for the silver & black with no logo, Ms. Baker seconded, and all voted in favor.

Gazebo Planting – Ms. Pangle reported on June 1st, 7 volunteers planted 187 native plants around the gazebo.

New Water Agreement with Boonsboro – Ms. Riner reported no updates.

FY 2025 Budget – Ms. Riner reported both budgets were introduced at the last meeting and need to be approved at this meeting. Mr. Hull motioned to adopt the Town budget with the adjustment for the MML dues and the Water budget, Ms. Kerns seconded, and all voted in favor.

Community Deputy Program Amendment – Ms. Riner reported we signed a copy but have not signed the original yet. There was some discussion about the increase and the Towns that may be dropping out of the program.

Paving - Ms. Baker has talked with them, and they plan to meet next week.

Multi-Sport Court Grant – Ms. Riner reported we were awarded \$350k, but it still needs to be approved by the State Board of Public Works. We should know sometime in June.

Verizon Antennas - Ms. Riner reported Verizon decided to use private property near the gun club for their antennas.

New Business

Pry Quilt Presentation – Ms. Gemeny received a call from the Heart of the Civil War to bring a group to view the quilt. It will be around October.

Audit Adjustments – Ms. Riner reported that SEK came out and did all the past year's adjustments that needed to be done in QuickBooks.

MML Dues Increase – There was much discussion. Mayor Lord said he plans to talk about this at the MML Conference next week. He feels there is not enough representation from western Maryland and has put his name in to be on the Board of Directors.

Council Comments

Ms. Baker asked about the plugs for the slides in the playground. Ms. Riner said she has not been able to get a response from the company. Ms. Baker also questioned changing out mulch for a different material. There was much discussion about potential upgrades to the playground.

Mr. Sweeney said the Council needs to vote on the lead and copper quotes. Quotes were received from 120 Water, The Eads Group, and EA Engineering. Mr. Sweeney feels 120 Water makes the most sense but wants to wait until Boonsboro meets next week and see where they are with the quotes. Mr. Sweeney motioned to move forward with 120 Water pending the Boonsboro meeting, Ms. Baker seconded, and all voted in favor.

Mayor Lord mentioned the vandalism in the park and a friendly reminder there are cameras in the park to record malicious activity. He asked about the 15 S Main Street lot and the streambank restoration. Ms. Riner reported that it is now scheduled for summer 2025. Mayor Lord asked about the drinking fountain project for Taylor Park, but there are no updates at this time. Mayor Lord said the trees planted by the State Highway Dept on the south end of town are dying and are making that area look bad. Ms. Riner said that it is private property. Mr. Hull mentioned it was an engineered rain garden put in by the State. Ms. Riner pointed out the weed ordinance does not include dying trees.

Ms. Riner reported the closer arm in the women's bathroom has been repaired.

Ms. Pangle mentioned the meeting with DNR (regarding the railbed lease) on Tuesday, June 11, 2024, for those who want to attend.

Ms. Kerns made a motion to move into closed session, Ms. Baker seconded, and all voted in favor. The meeting went into a closed session at 8:10~pm.

Closed Session Summary: A closed session was held on 6/5/24 at the Keedysville Town Hall to consider the acquisition of real property and consult with counsel. Mayor Lord, Assistant Mayor Sweeney, and Council Members Mr. Hull, Ms. Kerns, and Ms. Baker all voted in favor of closing the session. No members voted against it. No members were absent. This meeting was closed under the following provisions of the General Provisions Article § 3-305(b)(3) & (7). "To consider the acquisition of real property for a public purpose and matter directly related thereto," and "To consult with counsel to obtain legal advice." The topics discussed were the acquisition of real property and ongoing litigation. Persons present for this discussion were Mayor Lord, Mr. Sweeney, Mr. Hull, Ms. Kerns, Ms. Baker, Mr. Kuczynski, Ms. Riner, and Ms. Pangle. No action was taken.

The meeting entered back into open session at 9:05 pm.

Meeting adjourned at 9:05 pm.
