Old Business

Bird Strike Window Film Update – Window film was installed on 9/9/25 with the help of five GT members.

Contest for 250th/SpringFest 2026 – There was much conversation about the contest and prizes. Ms. Lord mentioned scaling back the contest to a more manageable level. She will work on that for the next meeting. It was decided to have 4 age groups (Pre-K to 2nd grade, 3rd – 5th, 6th to 8th, and 9th to 12th) with 3 prizes per age group. There was mention of connecting with homeschool kids. Ms. Lord is going to see how the American Legion engages with homeschoolers. Ms. Cooke mentioned having a 3D printer and could make kid-friendly planters with a baby plant in each.

Streambank Stabilization for Residents Update – The representatives from Catoctin Land Trust and the Maryland Forest Service have confirmed their attendance at our meeting on November 20th to discuss new funding opportunities and streambank stabilization for residents. Ms. Pangle mentioned there will be a preconstruction meeting for the town's streambank restoration on 10/3 at 11 am behind town hall. Mr. Krebill said he is off that day and can attend.

New Business

Fall Festival for 2027 and Beyond – Ms. Cooke suggested having a fall festival with speakers to talk about environmentally friendly ways to overwinter the garden, heat and insulate houses, and maybe a toy swap for the upcoming holidays. The team decided to begin by inviting speakers to GT meetings to determine if there is sufficient public interest or to help increase it.

The team decided participate in this year's grant opportunity and concentrate on the planting required around the multi-sport court, which should be completed around June 2026.
