The monthly meeting of the Keedysville Green Team was called to order at 7:05 pm with the following present: Mayor Ken Lord (@7:30), Team Members Sandy Lord, Evan Wiegand, and Administrative Assistant Teresa Pangle.

Announcements were read.

Old Business

Streambank Stabilization for Residents Update – Ms. Pangle will reach out to the representatives from Catoctin Land Trust and the Maryland Forest Service to verify their participation in our meeting on November 20th. The last week of October, Mr. Wiegand will post a flyer/event on social media to encourage community attendance.

Contest for 250th/SpringFest 2026 – Ms. Lord hasn't had time to work on this and requested we table this for next month. She may send updates via email before next month's meeting.

Fall Community Yard Sale – Mr. Wiegand said he didn't see much participation.

2025 Sustainable Maryland Grant Update – Following last month's meeting, it came to our attention that we can't plant around the multi-sport court due to grant funding conflicts. The team decided (via email) to do a mural on the park restroom building. The inside of the building is getting a renovation in 2026, but it does not include painting the outside. Ms. Pangle knows an artist and asked the team for ideas for what they would like to see in a mural design. She relayed that information to the artist. The artist came out to take measurements and provided a sketch and price to submit with the application. There was a discussion about applying for the full \$20k grant or just \$10k to cover the mural on the front of the building. The team decided to apply for the full \$20k. There was much discussion about whether to paint the other three sides with more design or just a coat of paint to complement the mural. It was also mentioned to put planters/landscaping in front of the

building to complement the mural. Ms. Pangle will talk with the artist to see what ideas she has for painting the other sides of the building to fit in the \$20k limit.

New Business

Wildlife Habitat Speaker – Ms. Cooke researched a speaker and provided a website to the Wildlife Habitat Advisor Program. It's a free service that offers wildlife-friendly spaces. The team chose to invite the speaker to the March meeting rather than the January one. Ms. Lord said we could call this our "Speaker Series", starting with the speakers who are coming in November, the wildlife speaker in March, and try to have someone in June.
